WAIVER AND RELEASE OF LIABILITY AND ASSUMPTION OF RISK ACKNOWLEDGEMENT

By this instrument I hereby release CCR II, any and all volunteers and all other persons and organizations involved in the CCR II. I understand that such participation can be dangerous and that the dangers may include damage to or destruction of personal property, serious physical injury or even death. I represent that:

1. I am 18 year of age or older.
2. I am submitting this release, waiver of liability, and assumption of risk declaration voluntarily and of my own free will.
3. I have had no physical or emotional problems, nor any history thereof, which will impair his/her ability to participate in the event.
4. I understand and EXPRESSLY ASSUME all the dangers incident to participating in this CCR II event and hereby RELEASE ALL CLAIMS, including but not limited to, personal injury, property damage or destruction, and death, whether caused by NEGLIGENCE, breach of contract or otherwise, and whether for bodily injury, property damage or loss or otherwise, which I may ever have against the CCR II, any of its officers, directors, employees, agents, volunteers, assigns, or successors and any other person or entity who is a participant in or promoter of this event as well as any supplier of materials and equipment employed in connection with my participation in the event;

I agree to assume all financial responsibility for any medical, rescue or other expenses that I may incur or may be incurred on my behalf and agree to defend, hold harmless and indemnify CCR II, any of its officers, directors, employees, agents, volunteers, successors and assigns for any loss or damage, including attorneys' fees, that they may suffer should I or anyone else on his/her behalf pursue an action or claim that is waived or barred by this release or waiver or any other claim by or on behalf of me arising out of the activity to which this release relates;
